We will never charge you for the platform and app or its services without making it very clear to you exactly what you're paying for.

We therefore recommend that you do not jailbreak or root your phone, which is the process of removing software restrictions and limitations imposed by the official operating system of your device. You can turn off auto-renew at any time from your iTunes account settings, but refunds will not be provided for any unused portion of the term. These prices are for customers from the Netherlands only. Pricing in other countries may vary and actual charges may be converted to your local currency depending on the country of residence.
